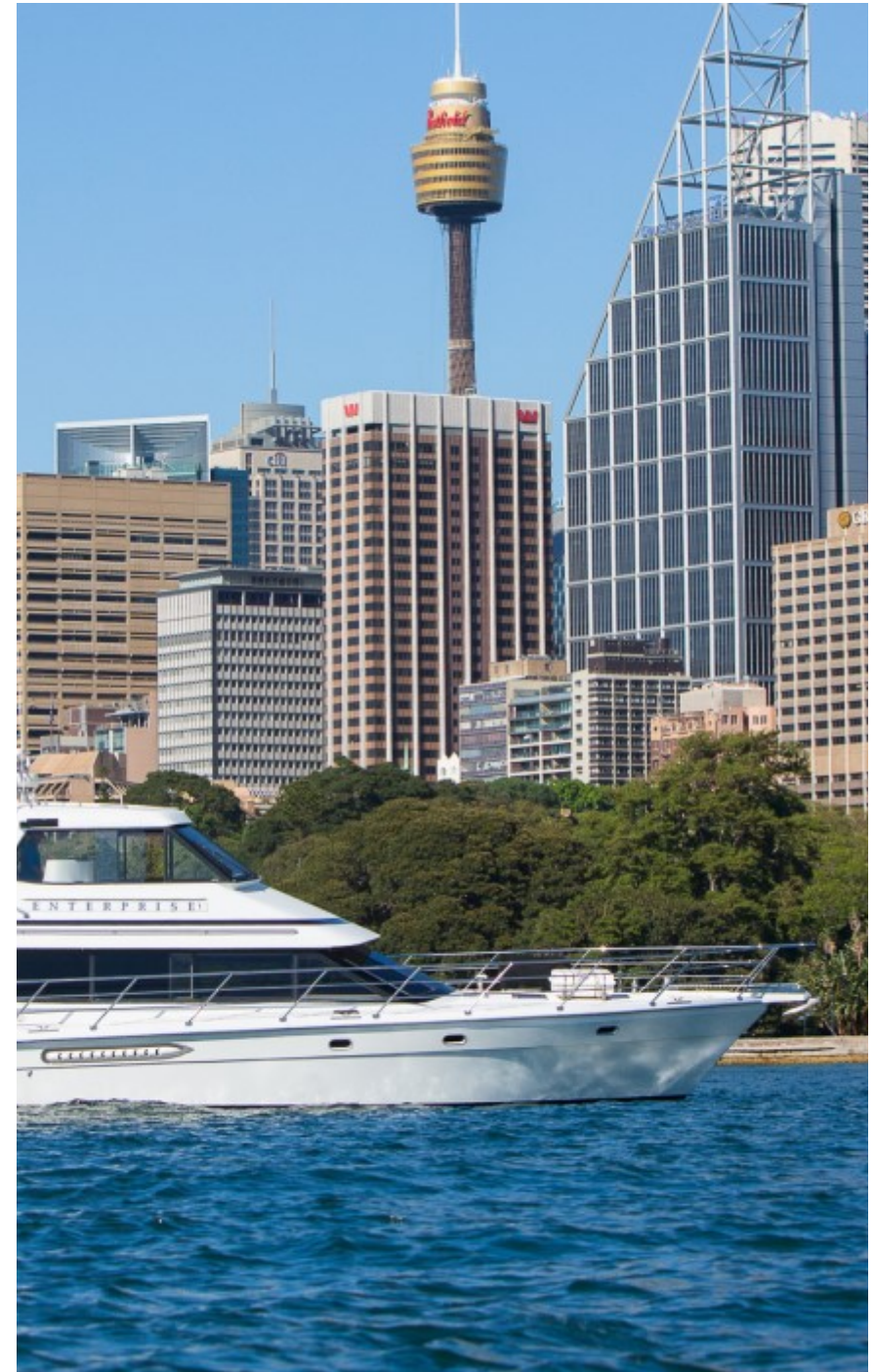

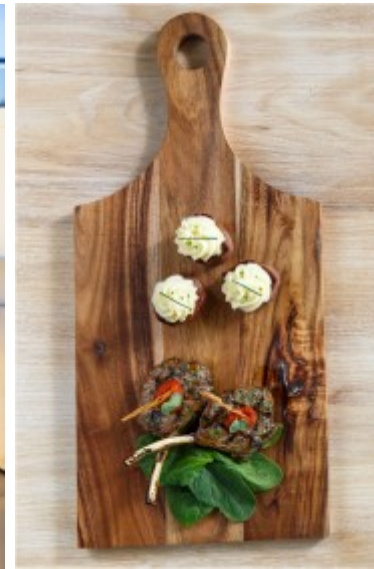

### BYO Option (subject to approval)

For up to 20 guests only. A flat service fee of \$500 per charter. Client must provide their own ice (4-5 bags per esky—2 eskies). We shall provide glassware only. BYO service fee includes the use of the onboard eskies, loading and rubbish disposal. BYO supplies cannot be loaded at a passenger wharf.



## CHARTER COSTS

**March – October:** \$700 per hour with minimum four hours per booking

**November – February:** \$800 per hour with minimum four hours per booking excluding Christmas Eve, Christmas Day, Boxing Day, New Year's Eve and Australia Day  
Prices for these dates available on request.

## STAFF & SERVICE

Charter rates include vessel, a fully qualified skipper and one deck hand.

**Other staffing requirements :** 1- 10 guests - No Additional staff      11 – 20 guests – 1 staff required      21 – 30 guests – 2 staff required  
Staff are charged out at \$55 per hour for the duration of the charter and are required for all charters  
On Board Chef charged at \$275 for four hours.

**BYO (subject to approval) :** BYO Beverage charged at \$500 per charter      BYO Catering charged at \$500 per charter  
(Glassware provided—client to provide ice)      (Client must provide their own condiments and serving ware including cutlery, plates, napkins etc)  
(Beverages and Catering must be loaded at Rose Bay Marina prior to departure)  
BYO beverage available only to charters up to 20 guests. Substantial catering must be arranged and confirmed with the vessel.  
BYO Catering available for all charters.

**Wharf Fees :** Wharf fees are charged at \$50 per wharf. Wharf locations need approval as not all wharves are suitable for the vessel.

Enterprise is a fully licensed vessel and staff are all trained in the responsible service of alcohol. If you have any special requests (ie. alternate catering menus and beverages) we are only too happy to source and accommodate this for you where possible. All prices include GST.

## TERMS AND CONDITIONS

- A Deposit of 50% of the Charter fee and the signed agreement is required to confirm your booking.
- A bond, in the form of the above credit card authorisation, must be provided at the time of booking, which will be held on file. The credit card authorisation will be debited in the event of loss, damages, overdue payments or cancellation.
- Full payment of the outstanding balance of the charter fees (including additional catering, beverages and wharf costs) are required 10 working days prior to your charter. If payment is not received we reserve the right to cancel your charter and retain your deposit.
- For approved 'on consumption' bar accounts payment is required at the conclusion of the cruise. We accept payment by cash, credit card or company cheque. Credit card payments will attract a surcharge fee of 1.5%
- If your confirmed charter is cancelled within 28 days of the confirmed date, 50% of the deposit is not refundable.
- If your confirmed charter is cancelled within 14 days of the confirmed date, 100% of the deposit is not refundable.
- MV Enterprise has a strict NO SHOE policy and guests shall be asked to remove their shoes upon boarding. Please advise your guests accordingly.
- Wharf fees apply. MV Enterprise embarks and disembarks at Rose Bay pontoon wharf. Alternative wharf locations subject to approval (Wharf Fees may vary).
- The charter course to be undertaken on the evening shall be determined by the Captain on the day as weather, traffic and exclusion zones need to be taken into account.
- Management does not permit you to bring any food or beverage of any kind aboard MV Enterprise unless prior permission has been obtained. Corkage fees apply.
- Prices and menus are subject to change. \*Payments via credit card will attract a 2% surcharge on amex/mastercard/visa and a 3% surcharge on diners.
- Please note as per the Liquor Act 1982 section 35 liquor may not be sold or supplied to a passenger on the motor vessel more than 1 hour prior to the vessel commencing the voyage and no later than 30 minutes after the voyage is completed.
- MV Enterprise adheres to the Responsible Service of Alcohol and the Captain on the day reserves the right to refuse any guest approaching intoxication to board the vessel. During the Charter the Captain reserves the right to cease service of alcohol to guests approaching intoxication. The Captain's decision on the day is final and no negotiations will be entered into. No refund will be given for guests refused boarding.
- MV Enterprise has a zero tolerance to illegal substances and the charter will cease immediately if any guest is found abusing same. No monetary compensation will be given to ceased charters.
- MV Enterprise has limitations on entertainment, it is the client's responsibility to obtain the vessel management's written approval in advance for any entertainment requests. Adult entertainment is not permitted.
- Underage guests are allowed subject to written approval. Prior to approval being given you need to provide us with the full names and ages of underage guests and their parents. MV Enterprise complies with strict guidelines under NSW Liquor License regulations, which determine the parameters under which minors are allowed or excluded from licensed premises. Under no circumstances are underage guests allowed to consume or obtain any alcoholic beverage. A breach of these terms will result in your Charter being terminated immediately and forfeit of all payments.
- In the event of rowdy, unruly or aggressive behaviour MV Enterprise reserves the right to cease the charter prior to the booked conclusion time and return all guests back to the disembarking wharf.
- Charters booked under false or misleading information may be cancelled at any time with full costs incurred.
